## Contractual Parties, Duration

## Payment for Service, Recurrent Payment Setup

The service **VAT-Light PLUS (yearly payment)** has yearly payment(s) of 24750 CZK (or 1011 EUR)  
The client selected **CZK Standing Order (Czech banks only)** as payment method.

In case of standing orders, it is the responsibility of the client to set this up correctly in the banking software. Payment details are on the invoice that was sent by email together with this contract. In case of payments by Stripe, the client's credit card will be automatically charged.

## Withdrawal of Subscription Service / Buyer's Remorse

The client has the right to withdraw from this agreement within 14 days counting from 08.03.2026. The client will receive a refund of 24750 CZK (or 1011 EUR), minus a processing fee of 10%.

## (Early) Termination / Pausing of Subscription Service

Entrepreneurship is **subject to change**. In case the client decides to stop entirely / pause making use of the service before the end of the contract (), fees for used services up to the early termination / pausing date will be recalculated according to the then-current regular individual prices for services published on tradelicense.cz.

The **termination fee** is 2 months of the monthly service fee, unless the service is terminated per the end date of . For termination, the client needs to send an email stating the desired date of termination. This date can not be in the past.

In case the client wishes to **only pause / suspend the service**, no termination fee is charged and any remaining sum will be converted to **credit towards the pay-as-you-go system**. The credit has a validity of 12 months starting from the desired date of pausing. For pausing, the client needs to send an email stating the desired date of pausing. This date can not be in the past.

## Non-compliance, Overdue payments

Termination may also be initiated by AxCo for reasons such as non-compliance to accounting standards / suspected malpractice, non-communication from the client's side, and / or overdue payments for service.

**Overdue** is defined as (due date + 14 days). Should payments be repeatedly / systematically overdue, the client may be required to prepay in full until the end date () in order to resume services.
